OUR SESSIONS DURING 2009 EUGEO CONGRESS IN BRATISLAVA, SLOVAKIA

The Commission used an opportunity to organize special sessions within EUGEO Congress in 2009. EUGEO Congress had been organized by the Slovak Geographical Society, Comenius University and Geographical Institute of the Slovak Academy of Sciences, in co-operation with geographical societies of the other Central European countries (especially Polish, Czech and Hungarian societies). The chance to meet during this congress also used, for example, IGU Commissions on Global Change and Human Mobility (C08.17) and Land Use and Land Cover Change (C08.25).

The wider context within which the Commission meeting had been organized, it allowed formation of more extensive stream of papers combining various inter-related issues of governance and political geography. The presence of the Commission meeting also expressed our participation during the Congress plenary sessions. Long term serving member of our Commission Steering Committee Professor Petr Dostál chaired first plenary session. One of the speakers during final plenary session had been Professor Jiří Blažek, our corresponding member and frequent participant on previous Commission meetings. We had five sessions providing enough time for discussions. Numerous congress participants outside those familiar with work of our commission visited our sessions. It was positive effect of having meeting within “congress” framework. Originally we had almost 30 papers submitted, but due to last moment withdrawals and program changes (some papers were presented from personal and organizational reasons in other sessions), finally we had 17 presentations altogether in “our” sessions. The final participation in Bratislava meeting had negatively influenced financial uncertainty and limits introduced in many institutions in relation to financial and economic crisis. It forced many participants to cancel their participation, as it was frequently indicated in our personal communication during the Spring and Summer 2009. I would like to express thanks to all papers’ presenters, session chairs as well as other participants.

Location: The Hebrew University of Jerusalem, Israel
Dates: 8-9 July 2010

Local government transformation concerns territorial configurations, inter-governmental relations, finance, democratic participation, governance culture, and development strategies, the latter involving inter-municipal collaborations, and inter-sectoral partnerships. The fundamental challenges of local self-government have essentially remained unchanged for decades, perhaps centuries, but rapidly changing economic, political and technological contexts have continuously transformed policy agendas of the local state.

The Jerusalem workshop aims to bring together scholars engaged in the study of local government and local governance: geographers, including those engaged in the activities of the IGU commission on Geography of Governance, as well as scholars from other disciplines, such as political science and public policy. Presentations on any aspect of local government, local governance and their relationship with urban development are welcome. We aim at a particular focus on cross-national perspectives, on assessments of the impact of economic and ideological transformations of the early 21st century on reform discourses, and on the implications of the above for prevailing theories of governance at the local and metropolitan/regional levels.

IGU GOG COMMISSION MEETING IN KATHMANDU, NEPAL IN 2011

The Steering Committee accepted proposal submitted by one of its members, Professor Pushkar K. Pradhan to have 2011 IGU GOG Commission meeting in Kathmandu, Nepal. This decision reflects the intention of the Commission to cover by its activities more regions around the world. It is appropriate place, closer especially to participants from Asia and Pacific region. The Commission already has very good experiences with previous successful conference organised under the co-ordination of Professor Puskar K. Pradhan in Kathmandu a few years ago.

The organising institute, the Central Department of Geography (CDG), is one of the leading and oldest departments of the Faculty of Humanities and Social Sciences, Tribhuvan University, established in 1958. CDG has been actively involved in running Master's and PhD Programmes in Geography, which is open to all disciplines for admission and in geographic research for the universities, national and international agencies. In addition to core physical and human geographic subjects, major subjects of attraction are regional planning, natural resources management, urban planning and governance - enterprises and public-private partnership, GIS and RS, agricultural transformation, climate change, etc. It is publishing regularly a geographic journal once a year. It has academic collaboration programmes with several universities across the world, including Norway, Switzerland, Austria, Germany, Japan, Thailand, UK & USA.

All activities related to this 2011 IGU GOG conference are initially planned for about a week. Major activity - conference with paper presentations, it will be held in the Kathmandu for three days. Next part of the programme will be field excursion planned for four days. It will focus on one of the world's renowned trekking sites in Pokhara and its surroundings - Sirubari Village or Ghalegaon Village in western Nepal.

The next Commission newsletter will provide more details concerning the conference participation and programme.
